A word from Denise Liebel, President and CEO of United Services for Children

The 2022-23 fiscal year brought bittersweet goodbyes and exciting beginnings. The agency began the year in the same building it had occupied since 1988. Within those walls, teachers and therapists transformed the lives of more than 10,000 children. We were grateful to have a space that allowed miracles to happen every day. Our aging facility had served us well!

An incredible opportunity appeared. In fall 2022, the agency purchased a 41,000 square-foot building at 3420 Harry S. Truman Blvd. in St. Charles. Modern and spacious, the newly renovated building would provide United Services with room to grow and the flexibility to meet the community's evolving needs.

M+H Architects, Vanstar Construction and Bax engineering assembled a remarkable team, turning 3420 into a place United Services could call home. The agency's staff prepared for the move throughout spring 2023, then flawlessly executed this complex operation during the summer. We were sad to say goodbye to the building that had been our home for so long, but joyful to enter a new, welcoming space that had been created just for our programs and the families we serve.

Throughout all of this, programs continued uninterrupted. We served more than 185 children through our early intervention programs, delivered outpatient therapy to 115 children, and provided support services to 190 families.

The past year might be the most important since the agency was founded in 1975. We are privileged to be the team that bridged the transition from the agency's past to its future. Thank you for supporting our mission during this exciting time of change and possibilities.






Early Intervention programs focus on young learners, age 18–36 months, who have been diagnosed with a developmental disability or delay. Children receive the support they need to develop and grow in social, language, motor and adaptive skills. Children are placed in one of three low-ratio, structured learning environments. Days and hours vary with the children's individual needs. Parents and caregivers play an important role, working with the agency's teachers and therapists to develop individualized strategies to address each child's needs.

Early Intervention programs:

- Learn and Play Together Children learn to separate from their parents, play with peers, accept and adapt to change, use language to communicate their wants and needs, and expand proficiency in a range of developmental skills.
- Building Blocks Focus on preparation for group learning. Children learn to follow classroom routines and transition more easily. Children work on "learning to learn" behaviors, like attending to their name, coming when called, and sitting for a task.
- Building Blocks Intensive Children learn to attend to people in their environment and build social motivation. Focus on engagement, communication, social play, toy play and sensory needs.

Outpatient Pediatric Therapy is available for children age birth through 15 years. Family members are an integral part of the therapy team — participating, planning and observing throughout the process. The agency's expert therapists work with families to address each child's unique needs. Therapy is available in individual and group sessions. Medicaid and all major insurance carriers are accepted. Therapy is in-network for most insurance plans. Financial assistance is available, thanks to support from community members.

Outpatient Therapy programs:

- Applied Behavior Analysis Treatment plans are individualized to help children with Autism Spectrum Disorder increase their skills and decrease challenging behavior.
- Occupational Therapy Facilitates fine motor manipulation, visual perception, sensory processing skills, eye-hand coordination and feeding skills.
- Speech/Language Therapy Works to foster the development of communications skills.
- Aqua Therapy Helps develop motor skills, a greater sense of awareness, increased mobility and strength, and improved sensory processing.





Family Support Services ensure that new families feel welcome. Wrap-around services help families with young children navigate life's daily challenges. Teachers, therapists and a licensed clinical social worker collaborate to provide ongoing assistance. Families receive personalized care, plus access to a variety of training programs and support groups.

- SIBSHOP A monthly sibling support group that offers siblings the opportunity to express their feelings and better understand their families.
- The Incredible Years An eight-session parent training program for families of children (2-5 years) who demonstrate significant language delays, have an autism diagnosis, or exhibit red flags for autism. Play and communication strategies promote children's emotional regulation, social competence, language skills, school readiness, and relationships with others.
- **Referrals** Frequently made to connect families with community resources.
- **Quarterly therapeutic group sessions** Offered in a camp format for children age 2–10 years.


